FC Vegas Academy ("the Club") does not provide or arrange transportation for players unless otherwise stated in writing. All parents/guardians must carefully read and agree to the following terms regarding transportation to and from practices, games, tournaments, events, and any club-related activity.

1. No Club-Provided Transportation

I understand and agree that:

- FC Vegas Academy does not provide buses, vans, or designated club transportation.
- All transportation arrangements — including carpools, rides with other parents, rides with coaches, rides with team volunteers, or independent teen transport — are privately arranged and not coordinated, supervised, or endorsed by the club.
- Any individual who provides transportation (parent, guardian, coach, team manager, volunteer, teammate, etc.) does so in a private capacity, not as an agent or representative of FC Vegas Academy.

2. Release of Liability

I hereby release, discharge, and agree to hold harmless:

- FC Vegas Academy
- Club owners, directors, coaches, staff, trainers, volunteers
- Field partners and facility owners
- Any other affiliated entities

from any and all liability, claims, demands, or causes of action that may arise out of or relate to:

- Car accidents
- Vehicle malfunctions
- Driver negligence or inexperience
- Mechanical issues
- Road conditions
- Traffic incidents
- Failure to use seat belts
- Injuries sustained entering/exiting a vehicle
- Delays, breakdowns, or transportation-related disputes

This release applies to:

- ✓ Trips to and from fields
- ✓ Transportation to tournaments or out-of-state play
- ✓ Rides provided by coaches or team staff
- ✓ Carpools arranged between parents
- ✓ Rides arranged through group chats, team pages, or messenger apps

I understand the Club is not responsible for verifying:

- Driver's licenses
- Insurance coverage
- Driving records

- Vehicle safety
- Seat belt or booster seat compliance

3. Parent/Guardian Responsibility

I agree that I am solely responsible for:

- Ensuring my child has reliable, safe transportation
- Knowing who is transporting my child
- Making sure seat belts/booster seats are used correctly
- Communicating transportation expectations with my child
- Approving or denying any ride for my child

I understand FC Vegas Academy cannot supervise or control my child once they leave club property.

4. Permission for Independent Transport
