- I will not receive compensation for the use of recordings or images.
- The club retains all ownership rights to recorded media.

4. Name Usage

5. No Expiration / Right to Revoke

This consent:

- May only be revoked by submitting written notice to club administration.
- Revocation will not apply retroactively to media already created or published.

6. Release of Liability

- Any claims arising from the use of my child's name, image, or likeness
- Any expectation of confidentiality
- Any expectation of privacy regarding recordings made at club activities
- Any compensation or damages related to media usage
